

# Overview of the Changes Promoting Interoperability Requirements for 2019

The purpose of this document is to compare the Promoting Interoperability (PI) objectives and measures for hospitals vs. Medicare clinicians under the Merit-based Incentive Program (MIPS) vs. Medicaid requirements. Under the Medicare hospital Promoting Interoperability (PI) Program and the MIPS PI performance category requirements, there is better alignment and new opioid measures are optional. Some measures have also been removed. Medicaid measures largely retain the previous Stage 3 construct however, CMS has made some changes.

### **KEY CHANGES:**

# Hospitals:

- Final IPPS rule here.
- 2019 Medicare measure specification sheets <u>here.</u>
- Under the public health measures hospitals now only must select any two measures rather than having to meet syndromic reporting plus one additional registry measure.
- New opioid measures are finalized as proposed, except the Verifying the Opioid Treatment Plan measure is now optional for both 2019 and 2020.
- Modified Stage 2 requirements for EHs in 2018 (included for comparison purposes only)

#### MIPS Clinicians:

- Final QPP rule here.
- · New opioid measures have been finalized.
- In 2018 clinicians could pick any two public health measures and earn 10 points for the first and 5 points for the second. For 2019 if a clinician reports on two measures they earn 10 points.

## Medicaid

- For 2019, CMS made changes to Objective 6, Coordination of Care Measures 1 (View, Download, Transmit) and 2 (Secure Messaging) for EPs; both remain at a threshold of 5%. Under Objective 8, Public Health Reporting, for Measure 2 (Syndromic Surveillance), CMS removed restrictions around urgency care settings; also, CMS did not change any requirements for registries that they had to accept data from EPs. If an EP meets the requirements of a registry, they can use it; if not, they can take the exclusion.
